


QUARTERLY DEBT BULLETIN AS AT 31 March 2019

INTRODUCTION

This Quarterly Debt Bulletin summarises the Public Sector Debt position of St. Kitts and Nevis from 31 March 2018 to 31 March 2019 in millions of EC currency. The data presented in the Bulletin covers the trend in the debt stock with a focus on External and Domestic Debt, Central Government's Debt and Government Guaranteed Debt. The Bulletin also highlights Total Debt Service payments, Debt Disbursements and Debt Sustainability and Risk Indicators.

1.0 TOTAL PUBLIC SECTOR DEBT

Total Public Sector debt stood at \$1,569.9m (55.4 percent of GDP) at the end of March 2019 (See Figure 1). Over the review period the debt stock declined by \$71.7m or 4.4 percent when compared to the comparative period of March 2018 (\$1,641.6m).




The most notable reductions in the debt stock occurred during the quarters ending June 2018 and December 2018 where the total amount of outstanding debt decreased by 1.2 percent and 5.4 percent respectively relative to the previous quarter. Conversely, the debt stock increased by 2.3 percent when the quarter ending September 2018 was compared to that ending June 2018. For the current quarter (March 2019), Total Public Debt increased marginally by 0.03 percent.

Central Government's share of the Total Public Sector Debt was 46.6 percent, a decline of 8.4 percentage points compared to March 2018 (55.0 percent) (See Figure 2). Over the review period, Central Government's Debt decreased by an average of 5.0 percent per quarter for a total decline of 19.0 percent. The most notable quarterly reduction in the debt stock was observed in December 2018 with a decline of \$107.7m.




Conversely, total guaranteed debt, comprising debt of the Nevis Island Administration (NIA) and Public Corporations, increased by an average of 3.2 percent per quarter and an overall growth of 13.4 percent.

The interest rate composition of the Total Public Sector Debt showed a decrease of \$59.0m in Fixed Rate debt from \$1,307.5m in March 2018 to \$1,248.5m by March 2019. Similarly, Variable Rate debt declined by \$12.7m from \$334.1m in March 2018 to \$321.4m in March 2019 (See Figure 3).



As at March 2019, domestic debt accounted for 74.9 percent of Total Public Debt while external debt accounted for the remaining 25.1 percent (See Figure 4).






2.0 EXTERNAL PUBLIC SECTOR DEBT

Figure 5 indicates that as at 31 March 2019, total external debt stood at \$393.6m (13.5 percent of GDP). Over the review period, external debt declined by \$23.0m or 5.5 percent. Central Government's external



borrowing accounted for 81.9 percent of total external financing while external borrowing by the NIA and Public Corporations in St. Kitts and Nevis comprised the remaining 18.1 percent.

The main sources of external debt financing as at March 2019 were Multilateral Creditors (49.6 percent) followed by Commercial Banks (23.6 percent) with Other Creditors and Bilateral Creditors accounting for 13.6 percent and 13.2 percent respectively (See Figure 6).



Fixed rate debt represented 54.5 percent of total external debt whereas variable rate debt accounted for the remaining 45.5 percent (See Figure 7).

As at March 2019, the United States Dollar remained the most dominant currency in the external debt portfolio. It accounted for 89.5 percent of total external debt (See Figure 8). The EC Dollar comprised 7.5 percent of external debt, Kuwaiti Dinars and Special Drawings Rights (SDR) totalled 1.3 percent and 1.4 percent respectively, and Euros 0.3 percent.




3.0 DOMESTIC PUBLIC SECTOR DEBT

As at March 2019, domestic debt was recorded at \$1,176.3m or 41.5 percent of GDP, a \$48.7m or 4.0 percent decrease compared to the corresponding period in 2018 (\$1,225.0m). The decline in the domestic debt was mainly attributed to a \$74.2m decrease in debt held by Other Financial Institutions and a \$2.7m reduction in outstanding obligations to Private Creditors. The reduction in the domestic debt was moderated by a rise in borrowings from the Social Security Board and Commercial Banks in the amount of \$16.9m and \$11.0m respectively.

The main holders of domestic debt were Commercial Banks (46.7 percent), the Social Security Board (27.0 percent), Other Financial Institutions (13.1 percent), and Private Creditors (11.9 percent) (see Figure 9).


4.0 TOTAL GUARANTEED DEBT

Total Guaranteed Debt outstanding was comprised of debt contracted by the NIA and the Public Corporations in both St. Kitts and Nevis. Total Guaranteed Debt was \$838.8m at the end of March 2019 with domestic debt accounting for \$767.7m (91.5 percent) and external debt representing the remaining \$71.1m (8.5 percent) (See Figure 10).



The majority of Total Guaranteed Debt was comprised of Loans (82.9 percent). Treasury Bills (11.9 percent), Overdrafts (3.2 percent), Other Liabilities (1.1 percent) and Bonds (0.9 percent) also contributed to the composition of guaranteed debt (see Figure 11).




As at March 2019, the Public Corporations' debt accounted for \$445.3m or 53.1 percent of the Total Guaranteed Debt while the NIA's debt represented \$393.5m or 46.9 percent.



5.0 CENTRAL GOVERNMENT'S DEBT

Central Government's Debt was recorded at \$731.1m with domestic debt accounting for \$408.6m

(55.9 percent) while external debt represented \$322.5m (44.1 percent).
