


INTRODUCTION

This Quarterly Debt Bulletin summarises the Public Sector Debt position of St. Kitts and Nevis from 31 March 2022 to 31 March 2023 in millions of EC currency. The data presented in the Bulletin covers the trend in the debt stock with a focus on External and Domestic Debt, Central Government's Debt and Government Guaranteed Debt. The Bulletin also highlights Total Debt Service payments, Debt Disbursements, Debt Sustainability and Risk Indicators.

ISSUE NO: 1 | March 2023

1.0 TOTAL PUBLIC SECTOR DEBT

Total Public Sector debt was EC\$1,581.5m (56.8 percent of GDP) at the end of March 2023 (See Figure 1). This represented a decline of EC\$15.3m or 1.0 percent compared to the March 2022 debt stock of EC\$1,596.8m (60.8 percent of GDP).




Total Public Sector Debt declined in June 2022 and September 2022 by EC\$4.6m and EC\$10.1m, respectively. The debt stock increased by EC\$11.6m in December 2022 then fell by EC\$12.2m in March 2023.



As at March 2023, Central Government's Debt accounted for 40.0 percent of the Total Public Sector Debt, remaining unchanged compared to March 2022 (40.0 percent) (See Figure 2). Over the review period, Central Government's Debt decreased by an average of 0.2 percent per quarter for a total decline of EC\$6.0m or 0.9 percent.




Total Guaranteed Debt, comprising debt of the Nevis Island Administration (NIA) and Public Corporations, declined by an average of 0.2 percent per quarter and exhibited an overall year-on-year reduction of 1.0 percent.



As at March 2023, Total Public Sector Fixed Rate debt decreased by EC\$4.3m to EC\$1,301.7m from EC\$1,306.0m in March 2022. Similarly, Variable Rate debt declined by EC\$11.0m from EC\$290.8m in March 2022 to EC\$279.8m in March 2023 (See Figure 3).



As at March 2023, Domestic Debt was 79.3 percent of Total Public Debt while External Debt accounted for the remaining 20.7 percent (See Figure 4).






2.0 EXTERNAL PUBLIC SECTOR DEBT

Figure 5 illustrates a trend of decreasing External Debt. Central Government's debt exhibited average

quarterly decreases of 0.2 percent contracting by 1.2 percent or EC\$3.5m over the review period. The debt of the NIA and Public Corporations also declined by 14.4 percent or EC\$7.3m from March 2022 to March 2023.




The primary source of the Public Sector's External Debt financing as at March 2023 was Multilateral Creditors (46.4 percent). External borrowing was also sourced from Commercial Banks (24.6 percent), Bilateral Creditors (16.5 percent) and Other Creditors (12.5 percent) (See Figure 6).





For the current period, debt contracted at fixed interest rates amounted to EC\$190.3m or 58.1 percent of total External Debt whereas variable rate debt accounted for the remaining EC\$137.4m or 41.9 percent (See Figure 7).



As at 31 March 2023, total External Debt was primarily denominated in United States Dollars which comprised 89.8 percent or EC\$294.1m of total External Debt.






Other currencies including Eastern Caribbean Dollar (8.3 percent), Kuwaiti Dinars (1.0 percent), Special Drawing Rights (0.8 percent) and Euros (0.1 percent) accounted for the remaining External Debt.

3.0 DOMESTIC PUBLIC SECTOR DEBT

Domestic Debt as at end March 2023 totalled EC\$1,253.8m or 45.0 percent of GDP. This reflected an EC\$4.5m or 0.4 percent decline compared to the corresponding period in 2022 (EC\$1,258.3m). The decrease was mainly on account of a reduction in debt owed to Social Security (EC\$6.5m) and Other Financial Institutions (EC\$3.3m).




The Public Sector's Domestic Debt was mainly held by Commercial Banks (48.7 percent), the Social Security Board (31.1 percent), Private Creditors (10.3 percent) and Other Financial Institutions (8.1 percent) (see Figure 9).



4.0 TOTAL GUARANTEED DEBT


Total Guaranteed Debt outstanding was comprised of debt contracted by the NIA and the Public Corporations in both St. Kitts and Nevis. Total Guaranteed Debt stood at EC\$948.5m at the end of March 2023 with Domestic Debt accounting for EC\$905.2m and External Debt representing the remaining EC\$43.3m (See Figure 10).




As at March 2023, loans were the dominant instrument (82.8 percent) of guaranteed debt. Guaranteed debt was also comprised of Treasury Bills (11.5 percent), Overdrafts (3.9 percent), Other Liabilities (1.2 percent) and Bonds (0.6 percent) (see Figure 11).

As at March 2023, Public Corporations' debt accounted for EC\$487.8m or 51.4 percent of the Total Guaranteed Debt while the NIA's debt represented EC\$460.7m or 48.6 percent.



5.0 CENTRAL GOVERNMENT'S DEBT

The Central Government's Debt of EC\$633.0m was comprised of Domestic Debt amounting to EC\$348.6m (55.1 percent) and External Debt of EC\$284.4m (44.9 percent).
